#### In Memoriam - Lewis S. Goodfriend, P.E.

It is with profound sorrow that we recently learned of the passing of Mr. Lewis S. Goodfriend at the age of 95. Lew was the 25<sup>th</sup> President of NJAIHA and served in 1969-70. Lew remained active in the section throughout the years, attending and presenting at meetings. The picture below shows Lew presenting at a NJAIHA dinner meeting in 2010.



The following additional thoughts about Lew was posted by the current president of Lewis S. Goodfriend & Associates - Mathew Murello, P.E.

It is with the deepest sadness that I report on the news of the passing of LSG&A's founder, Lewis S. Goodfriend. Lew passed away quietly in his sleep in the early morning of June 30<sup>th</sup> in his bed in Longmont, CO surrounded by his family. Lew was a proud Marine, serving from 1943 to 1945 in the Pacific theatre. In 1953, Lew founded LSG&A as one of the first acoustical consulting engineering firms in the area. Prior to founding LSG&A, Lew obtained a Mechanical Engineer degree from Stevens Institute of Technology and a Master of Electrical Engineering from Polytechnic Institute of Brooklyn. Lew went on to become one of the foremost experts in acoustical engineering. Lew was a Fellow of the Acoustical Society of America and the Audio Engineering Society. He was a Past President and former Member of the Board of Directors of the Institute of Noise Control Engineering, Senior Member of the Institute of Electrical and Electronics Engineers, and American Society for Testing and Materials, and served on the Board of Trustees of Stevens Institute of Technology. Lew was also was the first Editor of Sound and Vibration Magazine and the first Editor of Noise Control, a publication of the Acoustical Society of America.

# September 7, 2018 The Week in Review

#### AIHA Submits Comments to OSHA on Injury & Illnesses Tracking

AIHA has submitted comments to OSHA on their proposed rule on the tracking of workplace injuries and illnesses. With this rulemaking OSHA proposes to rescind the requirement for establishments with 250 or more employees to electronically submit information from OSHA Forms 300 and 301. OSHA argues that this move is necessary to protect worker privacy, which may be disclosed under the Freedom of Information Act (FOIA). AIHA disagrees and suggests alternative actions. #### California Updates Regulation on CIHs and Lead-Related Construction

In case you missed it, California recently issued a correction to regulations affecting the process by which CIHs become certified lead-related construction (LRC) inspectors/assessors or project monitors. The previous rulemaking unintentionally restricted the process by which CIHs become certified as LRC professionals. The new regulation goes into effect October 1, 2018. #### Congress Set to Approve New Funding for Worker Health & Safety Programs

The funding situation for worker health and safety programs is looking rather good in Congress. OSHA will likely get a \$4 million increase (\$556.8 million total); MSHA will be level-funded at \$373.8 million; NIOSH will also likely be level-funded at \$335.3 million. President Donald J. Trump proposed eliminating NIOSH's Education and Research Centers (ERCs), and recommended merging NIOSH into NIH; Congress is expected to reject both proposals.

Despite this good news, and the impressive progress that Congress has made in approving the yearly funding bills, Members of Congress and the President are once again entertaining the idea of a government shutdown. The issues at the center of this latest disagreement appear to be immigration and funding for President Trump's border wall. The new Federal fiscal year begins October 1, mere weeks before the midterm elections during which all members of the US House of Representatives and about one-third of US Senators are up for election. The threat of a shutdown and its proximity to the elections is causing splits within the Republican Party, with some arguing for fiscal responsibility and others in favor of pressure tactics to force Congress to approve funding for issues some of them campaigned on.

New Compliance Assistance Office + Two Websites Created by DOL

The US Department of Labor (DOL) has created a new Office of Compliance Initiatives, which is intended to strengthen the Department's compliance assistance through innovative solutions. DOL also unveiled two new websites, <a href="www.worker.gov">www.worker.gov</a> and <a href="www.employer.gov">www.employer.gov</a>, both of which contain useful information on workplace health and safety, and a variety of other important issues.

#### NIOSH Releases Final NORA for Traumatic Injury Prevention

What does NIOSH believe are the most important areas of research and urgent actions that need to be taken to prevent traumatic occupational injuries? The answers lie in the new <u>National Occupational Research Agenda (NORA) for Traumatic Injury Prevention</u>. The NORA lists eight objectives:

- 1) Prevent work-related motor vehicle crashes and injuries
- 2) Reduce falls and advance fall protection
- 3) Reduce violence in the workplace
- 4) Prevent injuries related to human-machine interaction for current and evolving technologies
- 5) Promote safety in non-standard work arrangements
- 6) Improve occupational safety equity across worker populations
- 7) Improve organization-based injury prevention

#### September is National Preparedness Month!

#### A Proclamation

National Preparedness Month is a time to focus our attention on the importance of preparing our families, homes, businesses, and communities for disasters that threaten our lives, property, and homeland. During this time, we also honor the brave men and women who selflessly respond to crises and disasters, rendering aid to those in need. These first responders, who work tirelessly to safeguard our Nation and protect our citizens, deserve our utmost gratitude and appreciation.

Over the past year, communities nationwide and across the Territories have witnessed and endured damage from multiple hurricanes, wildfires, tornadoes, floods, volcanic eruptions, and other natural disasters. The historic hurricane season of 2017 included three catastrophic storms that made landfall within a month, and was followed by a destructive series of wildfires in California. Combined, these natural disasters affected 47 million people and tens of thousands were mobilized to provide aid, comfort, and assistance. We are also especially mindful of those currently affected by ongoing wildfires in California, Oregon, and Colorado. In spite of tremendous challenges, the resilience of the American people continues to prevail.

Tragedies are somber reminders that preparedness is a shared responsibility and that it is critical to maintain readiness. All Americans can prepare for potential disasters by developing and practicing a family emergency response plan, assembling a disaster supply kit, signing up for alerts on mobile devices, setting aside emergency savings, and maintaining adequate insurance policies for their homes and businesses. The Federal Emergency Management Agency's Ready Campaign outlines other important steps to best prepare for a major disaster.

This month, I encourage all Americans to take the opportunity to ensure they have an emergency response plan in place and ready to be properly executed. Emergencies and disasters test the resilience and strength of families, communities, and our Nation. It is impossible to avoid every challenge and threat, but we can and must prepare for them. By doing so, we can help protect our communities and save lives.

NOW, THEREFORE, I, DONALD J. TRUMP, President of the United States of America, by virtue of the authority vested in me by the Constitution and the laws of the United States, do hereby proclaim September 2018 as National Preparedness Month. I encourage all Americans, including Federal, State, and local officials, to take action to be prepared for disaster or emergency by making and practicing their emergency response plans. Each step we take to become better prepared makes a real difference in how our families and communities will respond and persevere when faced with the unexpected.
