OSHA's COVID-19 Vaccine, Testing Rule Is in Review

OSHA has submitted the initial text of its emergency temporary standard to require COVID-19 vaccination or testing for workers of larger employers to the Office of Management and Budget for review, a Department of Labor spokesperson confirmed on Oct. 12.




NJAIHA Confers 2021 Student Scholarships

A traditional event which takes place during our annual year-end June dinner meeting is the presentation of scholarships to deserving and qualifying students who have demonstrated scholastic excellence in the study and promotion of environmental health and safety/industrial hygiene at the collegiate undergraduate or graduate levels. And, for the past few years, our scholarship program has been opened to high school senior year level students with some experience in a STEM (science, technology, engineering, mathematics)-oriented educational curriculum, and who have expressed an interest in pursuing a STEM-based curriculum, or preferably an IH/occupational and environmental health and safety (OEHS)-based curriculum at the collegiate level.

This year, unfortunately due to still on-going Coronavirus (COVID-19) considerations, our 2021 scholarships had to be conferred on line during the virtual June 2021 year-end meeting. 





OSHA releases proposed rule on hazardous heat

OSHA has released its advance notice of proposed rulemaking to protect indoor and outdoor workers from hazardous heat. Comments are due on or before December 27, 2021. AIHA has already assembled more than a dozen volunteers to draft our comments to OSHA. We're active in both Maryland and Virginia as they draft their own, similar standards, so we're ready to go!
