

Publications Director's Note

Although OSHA's COVID-19 Emergency Temporary Standard (ETS) for large employers has been stayed <u>after court decisions finding that the agency exceeded its rulemaking authority</u>, OSHA continues to work on a standard that it hopes will pass legal muster;

Statement on the Status of the OSHA COVID-19 Vaccination and Testing ETS

January 25, 2022

The U.S. Department of Labor's Occupational Safety and Health Administration is withdrawing the vaccination and testing emergency temporary standard issued on Nov. 5, 2021, to protect unvaccinated employees of large employers with 100 or more employees from workplace exposure to coronavirus. The withdrawal is effective January 26, 2022.

Although OSHA is withdrawing the vaccination and testing ETS as an enforceable emergency temporary standard, the agency is not withdrawing the ETS as a proposed rule. The agency is prioritizing its resources to focus on finalizing a permanent COVID-19 Healthcare Standard.

OSHA strongly encourages vaccination of workers against the continuing dangers posed by COVID-19 in the workplace.

AIHA National continues to update their new website collecting COVID-19 reopening information. It's been endorsed by several high-profile personalities and organizations for its timeliness and scope;

"Rubber bands, a low-cost and easily-accessible modification, can improve the seal and protective ability of a standard surgical mask to the level of an N95 respirator. This could mitigate N95 respirator shortages worldwide and provide individuals in under-resourced regions a practical means for increased personal respiratory protection."

With the focus turning away from COVID-19 at the federal and state level, OSHA is launching a major initiative aimed at reducing worker injuries and illnesses in warehouses and other storage and distribution facilities. The astonishing growth in size and number of facilities tied to online shopping, particularly in our region, and the significant increase in employment in the sector has drawn attention from many quarters to "do something" about injuries and illnesses.

US Department of Labor launches 5-year initiative in Mid-Atlantic states to reduce worker injuries, illnesses in warehousing, storage, distribution yards

PHILADELPHIA – The U.S. Department of Labor's Occupational Safety and Health Administration recently launched a regional initiative in three Mid-Atlantic states and the District of Columbia in an effort to protect workers and reduce injuries and illnesses in the warehousing, storage and distribution yards' industries.

OSHA's Regional Emphasis Program for Warehousing Operation focuses on industry employers in Pennsylvania, Delaware, the District of Columbia and West Virginia.

"With the rapid growth of e-commerce, the warehousing industry has significantly expanded. This emphasis program will address hazardous conditions these workers continuously face every day," explained OSHA Regional Administrator Michael Rivera in Philadelphia. "Through coordinated outreach, education efforts and on-site inspections, OSHA is determined to identify hazardous workplace conditions and hold industry employers accountable for providing a safe and healthful workplace."

The initiative follows a Bureau of Labor Statistics' 2020 finding that the warehousing and storage industry's injury rate of 4.8 per 100 workers is higher than the U.S. average of 2.7 per 100 rate among all private industries. In addition, from 2017 to 2020, BLS reported 93 work-related fatalities nationally in the industry.

OSHA's emphasis program began on Aug. 3, 2022, with a three-month period of outreach aimed at education and prevention. During this time, agency representatives will share safety and health information with employers, trade associations, workers and other stakeholders. OSHA encourages employers to review operations at their warehousing, storage and distribution facilities before the program's second phase, focused on ensuring compliance with federal safety and health standards.

In fall 2022, OSHA will begin targeted enforcement, incorporating on-site inspections to identify safety and health hazards, including those typically found in the warehousing industry. These include those related to the use of powered industrial trucks, such as forklifts, lockout/tagout procedures, machine guarding, means of egress, and fire suppression. Inspections will not include marine terminals or shipyards.

The emphasis program ends Aug. 3, 2027, unless extended. The program supplements the work of OSHA's area offices as they continue to open inspections in response to complaints, hospitalizations and fatalities.

NIOSH Develops National Firefighter Registry

Fighting fires is a dangerous profession, and the danger goes beyond the hazards of running into a burning building. Numerous studies show that firefighters' exposure on the fireground, where smoke and hazardous chemicals are released from burning materials, may increase their risk of cancer and other chronic diseases. While the association between firefighting and disease



seems clear, more information about these health risks is needed especially with regard to the higher risk of cancer among firefighters.

To better understand the link between on-the-job exposure to toxicants and cancer, Congress mandated, through the Firefighter Cancer Registry Act of 2018, that the Centers for Disease Control and Prevention (CDC) create the National Firefighter Registry (NFR). The National Institute for Occupational Safety and Health (NIOSH) is leading the effort to create this voluntary registry of firefighters, with input from the scientific and firefighting communities.

The NFR will be used to track and analyze cancer trends and risk factors among the U.S. fire service to help the public safety community, researchers, scientists and medical professionals find better ways to protect those who protect our communities and environment. All firefighters, structural and wildland, career and volunteer, active and retired, should consider participating in the NFR. This includes firefighters who have never received a cancer diagnosis, previously had cancer, or currently have cancer.

NIOSH is developing an online NFR enrollment system. If you know of an individual or individuals who might qualify for the NFR and would be interested in enrolling in it, please pass this notice along and have them access two NFR information documents at NFR Pamphlet and NFR Fact Sheet, and have them access the National Firefighter Registry Page on NIOSH's website at https://www.cdc.gov/niosh/firefighters/registry.html

April 2022 NJAIHA Meeting - Past Presidents' "Night" (Virtual) - 4/21/22





Mr. Baker's talk, "OSHA Update for Healthcare" provided attendees with, among other things, the latest status of OSHA's COVID-19 Healthcare Emergency Temporary Standard (ETS), a review of those provisions of the ETS remaining in effect, and a discussion of OSHA citations issued relative to COVID-19.

February 2022 NJAIHA Meeting (Virtual) - 2/24/22



On Thursday, 2/24/22, NJAIHA held a virtual meeting with <u>Bryan Seal</u>, PHD, CIH, CSP, CHMM, REHS, serving as our technical speaker (above). Dr. Seal, currently an Assistant Professor in the Safety Sciences Department of Indiana University of PA, gave a very practical talk, "Importance of a Basic IH Field Kit", for industrial hygienists where he discussed the importance of having an Industrial Hygiene Field Kit. Brian inventoried what supplies, tools and essential monitoring equipment should be in such a Kit and reviewed what rotating equipment an industrial hygienist should include in the Kit depending on the type of site survey being performed.

During the talk, he introduced what an industrial hygienist's "Go Bag" is and summarized what essential items always belong in it, and highlighted what specialty items may be needed on a survey and whether it made sense to buy or rent them.

It should be noted that an earlier version of this presentation was given by Dr. Seal in collaboration with RAECO Rents of Gurnee, IL. And in fact, Randy Walkowiak of RAECO Rents co-introduced Dr. Seal along with Brian Feury, NJAIHA President.

NJAIHA Confers 2022 Student Scholarships

Governor Murphy Signs Executive Order Lifting Routine COVID-19 Testing Requirements for School Districts, Child Care Settings, and State Contractors

TRENTON – Following recent updates to COVID-19 guidelines from the Centers for Disease Control (CDC) in advance of the upcoming school year, Governor Phil Murphy today signed an executive order lifting the requirement that school districts, child care settings, and state contractors maintain a policy requiring their unvaccinated workers undergo routine testing. The change will apply to school districts and child care settings immediately, and to state contractors as of September 1, 2022.

As of June 17, 2022, anyone aged 6 months or older is eligible for the COVID-19 vaccine. At this time, more than 18.4 million doses of the COVID-19 vaccine have been administered in New Jersey, with more than 1.9 million doses having been administered to children under the age of 18.

"Today's executive order follows guidance from public health officials at the CDC regarding responsible steps states can take as we continue to adjust to the endemic reality of COVID-19," said Governor Murphy. "With children as young as 6 months old now eligible for vaccines and millions of New Jerseyans vaccinated and boosted, more of our residents are safe from severe illness due to COVID-19. As always, I encourage everyone to stay up-to-date on their vaccination and take other precautions as necessary to protect themselves and their loved ones from this virus."

This executive order lifts the testing requirements put into place for school districts, child care settings, and state contractors via previous executive order numbers 253, 264, and 271, respectively. Nothing in today's order prevents these settings from maintaining a vaccination or testing policy as they see fit going forward.

Schools and child care facilities will still be required to report vaccination and testing data to the Department of Health, as per Executive Directive No. 21-011, to allow the State to continue to monitor COVID-19 and make data-driven decisions to keep residents safe.

Covered workers in congregate care, health care, and correctional facility settings will still be required to be up-to-date on their COVID-19 vaccinations, including the first booster dose, as per prior executive orders.

Separate of today's executive order, the New Jersey state employee testing program will also come to an end on September 1, 2022.

Vaccination Details

For New Jersey's vaccine requirements for health care facilities and high-risk congregate settings, workers are considered "up to date with their COVID-19 vaccinations" if they have received a primary series which consists of either a 2-dose series of an mRNA COVID-19 vaccine or a single dose COVID-19 vaccine, and the first booster dose for which they are eligible. It is recommended, but not required, that workers receive any additional booster doses for which they are eligible under CDC recommendations.

Workers can show proof of full vaccination by presenting:

the CDC COVID-19 vaccination card issued at the vaccination site, or an electronic or physical copy;

the official record from the New Jersey Immunization Information System (NJISS) or other immunization register;

a record from a health care provider's portal or medical record system on official letterhead signed by a licensed physician, nurse practitioner, physician's assistance, registered nurse, or pharmacist;

a military immunization or health record from the United States Armed Forces; or

Docket mobile phone application record or any state-specific application that produces a digital health record.
