Starting June 13, 2023, The New Jersey Section of the American Industrial Hygiene Association (NJAIHA) is offering a comprehensive Industrial Hygiene Review Course. This course consists of a series of educational lectures given by leading industry professionals. 

This issue sees the CDC catch up to what many of us have been doing in practice for the last three years, a major blastomycosis outbreak resolves without pinpointing the source, and CalOSHA discovers that cutting quartz countertops without controls causes silicosis (HT The Synergist).

CDC Issues Building Ventilation Guidance to Guard Against Respiratory Infections

The Centers for Disease Control and Prevention (CDC) last week published guidance for improving building ventilation to help protect people from respiratory infections, with a goal of at least five air changes each hour and an upgrade to MERV-13 filters. U.P. Paper Mill Tied to Fungal Outbreak to Reopen

The Upper Peninsula paper mill linked to a rare fungal infection that left one worker dead and affected more than hundred others has moved toward reopening, officials said. The Escanaba Billerud Paper Mill "initiated resumption of operations" as of Monday following a deep cleaning, the company said in a statement. California Regulators Drafting Emergency Rule to Combat Deadly Lung Disease

Workplace regulators in California are drafting an emergency rule to address an epidemic of silicosis — a deadly, preventable lung disease — among fabricators of artificial-stone countertops. In December, Public Health Watch, LAist and Univision revealed what's believed to be the nation's biggest cluster of the disease, in the Los Angeles area. The news outlets' stories — and a petition citing them — triggered a burst of activity by California's Division of Occupational Safety and Health, known as Cal/OSHA. One of the men featured in the stories, Juan Gonzalez Morin, died last month. He had just turned 37. Since 2019, the California Department of Public Health has identified 69 cases of silicosis among fabrication workers — "likely an underestimate," the department said in a statement this week.





Federal:

<u>US Department of Labor announces more than \$12M in grant funding available for worker safety, health training grants</u>

WASHINGTON – The U.S. Department of Labor today announced the <u>availability of more than \$12.7</u> <u>million</u> in funding to make <u>more good jobs available to the U.S. workforce</u> by supporting training initiatives designed to promote safe and healthy in the nation's workplaces.

Administered by the department's Occupational Safety and Health Administration, the <u>Susan Harwood Training Grant Program</u> includes funding opportunities for Targeted Topic Training, Training and Educational Materials Development, and new Capacity Building training grants for nonprofit organizations. Grants will support recipients' efforts to provide instructor-led remote and in-person hands-on training for workers and employers in small businesses; industries with high injury, illness and fatality rates; and vulnerable workers, who are underserved, have limited English proficiency, or are temporary workers.

Specifically, the <u>Harwood grants</u> will fund training and education on how to recognize, avoid and control hazards, and inform workers of their rights and employers of their responsibilities under the Occupational Safety and Health Act. Funding will be available in the following categories:

- Targeted Topic Training: Supporting educational programs that identify and prevent workplace hazards. Applicants must conduct training on OSHA-designated workplace safety and health hazards.
- Training and Educational Materials Development: Supporting the development of quality classroom-ready training and educational materials that identify and prevent workplace hazards.
- Capacity Building: Supporting organizations in developing new training programs to assess needs and plan for full-scale safety and health education programs, expanding their capacity to provide workplace safety and health training, education and related assistance to workers and employers.

Applicants must register with grants.gov and SAM.gov to apply for a grant opportunity. Submit applications at www.grants.gov by 11:59 p.m. EDT on July 7, 2023.

OSHA will host a webinar, "How to Prepare a Competitive Susan Harwood Training Grant Application," to assist organizations in preparing grant applications on May 25, 2023, from 1 p.m. to 2:30 p.m. EDT. Register for the webinar.

US Department of Labor places New Jersey manufacturer in Severe Violator Enforcement Program after worker suffers serious, preventable amputation

United Hospital Supply Corp. faces \$498K in penalties after November 2022 incident

BURLINGTON, NJ – An employee's first day of work at a southern New Jersey manufacturing facility ended tragically when he suffered the amputation of three fingers while operating a press brake without required safety guards, similar to violations cited by federal safety investigators at the facility in 2010 and 2015.

After the incident prompted a complaint to the U.S. Department of Labor, investigators with the department's <u>Occupational Safety and Health Administration</u> began two investigations at United Hospital Supply Corp. in Burlington in November 2022.

OSHA <u>cited the company</u>, which produces metal products for hospitals, laboratories and schools, for a willful violation because supervisors and employees deliberately bypassed the press brake's light curtain, which led to the amputation. The agency also cited United Hospital Supply for willfully failing to remove and repair an inoperable forklift and to provide hazard communication training for chemicals used in the facility. OSHA has cited the company for the forklift and chemical training violations in its inspections dating back to 2010.

The agency also found the company exposed workers to welding fumes above the permissible exposure levels, did not provide respirators when needed, failed to develop a lockout/tagout program to prevent accidental machine startup and did not provide lockout/tagout training.

Following the November inspections, OSHA cited United Hospital Supply Corp. for three willful violations, 17 serious violations and one other-than-serious violation and proposed \$498,464 in penalties. For the company's intentional disregard and willful violations, the agency has placed United Hospital Supply in OSHA's Severe Violator Enforcement Program.

"Despite previous citations and penalties, United Hospital Supply Corp. has ignored its responsibility for protecting the safety and health of its employees," said OSHA Area Director Paula Dixon-Roderick in Marlton, New Jersey. "Machine guarding is a basic safety measure for reducing dangerous hazards

for machine operators which, in this case, could have prevented a new employee from suffering a traumatic life-changing injury."

United Hospital Supply Corp. manufactures steel cabinets, lockers, laboratory hoods and other metal products for hospitals, laboratories and schools. Founded in 1976, the company employs about 100 employees represented by Local 19 of the Sheet Metal Workers Union in Philadelphia.

The company has 15 business days from receipt of citations and penalties to comply, request an informal conference with OSHA's area director, or contest the findings before the independent Occupational Safety and Health Review Commission.

NJ Labor Department Highlights Surfboat and Lightning Safety in Advance of Summer Season May 23, 2023

TRENTON – As the unofficial start of summer approaches this Memorial Day weekend, the New Jersey Department of Labor and Workforce Development (NJDOL) is bringing attention to two <u>Safety</u> Alerts issued regarding surfboats and lightning exposure.

The NJDOL's Office of Public Employees Occupational Safety and Health (PEOSH) posted the alerts to ensure public employers and employees, particularly our beach patrols, are aware of the risks involved when operating a <u>surfboat</u> or in a situation of increased risk of <u>lightning strike</u>. Each alert details the possible hazards involved, as well as steps to mitigate worker injury or death.

"The Jersey Shore is a premier family-fun destination for locals and visitors alike, and our beach patrols are crucial to ensuring everyone stays safe while having a memorable visit," said Labor Commissioner Robert Asaro-Angelo. "NJDOL is proud to be part of our state's signature tradition by protecting these workers so they can safely perform their essential duty."

In 2022, PEOSH, which is responsible for inspecting, investigating, and educating workers and employers on workplace safety matters to ensure the safety and health of employees, performed a total of 58 inspections of beach patrols employing public employees in Monmouth, Ocean, Atlantic, and Cape May counties. Compliance officers found violations relating to boat hazard assessments, boat hazard assessment certifications, lightning policies, and record keeping. The expansive effort was prompted by the August 2021 tragic deaths of two young lifeguards, 16-year-old Norman Inferrera III, whose surfboat capsized at Cape May's Reading Avenue Beach, and 19-year-old Keith Pinto, who was struck by lightning while stationed on a lookout tower at White Sands Beach in Berkeley Township.

PEOSH compliance officers were deployed to the Cape May and Berkeley Township beaches following each incident to investigate associated safety concerns. After learning of the potential boatand lightning-related hazards faced by beach workers, PEOSH initiated the large-scale inspection project to spread knowledge and awareness of these dangers in an effort to prevent future tragedies.

(Clicking on their names brings up a window with useful information about each official.) The "Compose Message" button allows you to write an email to your official. You can select the subject and message that's right for you.
