Publications Director's Note

In This New-Jersey-Focused Edition, A Vegetable-Processing Facility and a Commercial Laundry Fail to Implement Lockout/Tagout Procedures Resulting In Two Injuries, One Fatal

US Department of Labor proposes more than \$1M fine following worker fatality at New Jersey vegetable processing facility

WASHINGTON – The U.S. Department of Labor has cited a fresh-cut vegetable processing company for willfully and repeatedly violating safety requirements after a worker was fatally injured while cleaning and sanitizing a machine.

In May 2025, the department's Occupational Safety and Health Administration initiated an inspection into Taylor Farms New Jersey Inc. after being notified of the fatality at its processing facility in Swedesboro, New Jersey. Inspectors determined that Taylor Farms, a subsidiary of Taylor Fresh Foods Inc., failed to implement proper lockout/tagout procedures to protect workers from severe injuries during sanitation activities.

OSHA cited Taylor Farms for 16 safety violations related to the lack of lockout/tagout procedures, as well as failure to implement lockout/tagout requirements or provide training, and proposed penalties totaling \$1,125,484. Additionally, PL Solutions Group LLC, operating as People Logistics, the onsite temporary employment agency, was cited for three serious violations with proposed penalties of \$33,100 for not implementing or training workers on lockout/tagout procedures.

US Labor Department cites New Jersey commercial laundry company after worker injured at Kearny facility

KEARNY, **NJ** – The U.S. Department of Labor cited a commercial laundry company for alleged workplace safety hazards after an employee injury at its Kearny facility.

The department's Occupational Safety and Health Administration opened an investigation of KNY 26671 LLC, operating as Cooperative Laundry, following a referral from the Kearny Police Department. OSHA inspectors determined that on Jan. 18, 2025, a worker suffered serious injuries while performing maintenance on an industrial dryer.

The agency cited Cooperative Laundry for three willful and nine serious violations for failing to evaluate permit required confined spaces, notify employees of the confined spaces, develop a permit confined space program, and utilize lockout/tagout procedures to prevent accidental machine startup.

The employer was also cited for neglecting to provide training to authorized employees, exposing workers to unguarded vertical and inclined belts, and failing to conduct periodic inspections. OSHA has proposed \$252,994 in penalties.

"Modern occupational environmental, health and safety (EHS) practices are key to driving economic growth. ...(D)espite advancements, workplace injury and fatality rates remain stagnant. By adopting proactive, risk-based safety strategies, businesses can unlock greater productivity, reduce costs and strengthen their global competitiveness. We urge today's business leaders and policymakers to prioritize occupational EHS as a foundation of economic competitiveness. Strengthening the Occupational and Environmental Health and Safety Pipeline

The Challenge and Need for Action - The Shortage of OEHS Professionals

"The American Industrial Hygiene Association (AIHA) and other stakeholders have observed a worrisome trend: not enough new professionals are entering the occupational and environmental health and safety (OEHS) field to replace retiring specialists or meet growing demand for their skills. This talent gap is reaching a critical point. OEHS roles, including those in industrial hygiene, occupational health, environmental health, and safety, are essential for identifying and controlling hazards that can cause injury, illness, or death to workers."

"When workplaces lack OEHS expertise, hazards often go unnoticed or unmanaged until incidents occur. In essence, a shortage of OEHS professionals translates directly to heightened risks for workers and the public. Businesses, schools, hospitals, and government agencies all face complex health and safety challenges, from chemical exposures and dangerous machinery to poor indoor air quality and infectious diseases. If there are too few experts to guide risk management, the likelihood increases that accidents, occupational diseases, and environmental health crises will occur."

"AIHA is sounding the alarm before the shortage becomes a crisis. We know from experience that effective occupational health and safety programs save lives and improve communities. Each industrial hygienist or safety specialist who enters the workforce prevents countless injuries and illnesses over their career. Conversely, each unfilled OEHS position leaves a gap that allows hazards to go unmitigated.."
